Q Why should we choose your payroll service?

A Our payroll is designed for Personal Employers who employ their own care/support workers.

Q What about Pensions?

Q What is a Managed Account?

A We open a dedicated bank account for your Direct Payment to be paid into. We manage this account on your behalf.

Q Does it include payroll?

A Yes, our Managed Account service includes Payroll. We also pay invoices/bills from this account.

Q How can I keep track of what has been spent?

A We complete an audit (monitoring) report each period which we send to you and your Local Authority.

Q Can I access the bank account?

A No, only Partners in Personalisation have access to the bank account.
